4 for adoption in the Tohono O'Odham Nation pursuant to
5 Section 2 of Article II of the Constitution of the
6 Tohono O'Odham Nation; and

7 WHEREAS, the Enrollment Committee has reviewed the respective
8 applications, and has made a final determination that
9 GARCIA-RUIZ, Alejandro; NICHOLS, Sophia; SALADIN, Sally
10 and SANRIOQUEZ-SOLANO, Concepcion are 1/2 degree or more
11 of Papago-Tohono O'Odham Indian blood, and has made a
12 recommendation to the Tohono O'Odham Legislative
13 Council that the applications be approved, all in
14 accordance with the provisions of the Enrollment
15 Ordinance; and

16 WHEREAS, the Tohono O'Odham Legislative Council has reviewed the
17 recommendations of the Enrollment Committee and the
18 evidence submitted in support of the individual
19 applications.
