Council by Section 3 of Article II and Article VI Section 1 (h) of  
the Constitution of the Tohono O'odham Nation on January 18, 1986,  
and approved by the Acting Deputy Assistant Secretary -Indian  
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of  
the Act of June 18, 1934 (48 Stat. 984).
