3 WHEREAS, Section 4 of Article VIII of the Constitution of the  
4 Tohono O'Odham Nation charges the Tohono O'Odham  
5 Legislative Council the responsibility of appointing  
6 judges of the Tohono O'Odham Courts; and

7 WHEREAS, a vacancy exists for a full time Judge's position; and

8 WHEREAS, the Judiciary Committee of the Legislative Council did  
9 forward the candidates applications to the Legislative  
10 Council for review; and

11 WHEREAS, the Tohono O'Odham Legislative Council did interview the  
12 candidates and did review the candidates' qualifications  
13 and is prepared to make an appointment.

14 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative  
15 Council that it hereby certifies the appointment of Evelyn  
16 B. Juan as a full time Judge of the Tohono O'Odham Courts  
17 to fill a six year term expiring on February 1, 1997.

18 The foregoing Resolution was passed by the Tohono O'odham Council  
19 on the 5th. day of June, 1991 at a meeting at which a quorum was  
20 present with a vote of 1,139.0 for; 528.0 against; 57.0 not  
21 voting; -0- absent, pursuant to the powers vested in the Council  
22 by Section 4 of Article VIII of the Constitution of the Tohono  
O'odham Nation, adopted by the Tohono O'odham Nation on January 18,  
1986, and approved by the Acting Deputy Assistant Secretary -  
Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
16 of the Act of June 18, 1934 (48 Stat. 984).
