Escalante as a full time Judge of the Tohono 16 O'Odham Courts to fill a six year term expiring on February 1, 1997. 18 19 The foregoing Resolution was passed by the Tohono O'odham Council

on the 5th. day of June, 1991 at a meeting at which a quorum was present with a vote of 1,307.5 for; 336.0 against; 81.5 not voting; -0- absent, pursuant to the powers vested in the Council 21 by Section 4 of Article VIII of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 22 1986, and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 23 16 of the Act of June 18, 1934 (48 Stat. 984).
