(Certifying the Appointment of Mary A. Juan
as Judge of the Tohono O'Odham Courts)

3 WHEREAS, Section 4 of Article VIII of the Constitution of the
4 Tohono O'Odham Nation charges the Tohono O'Odham
5 Legislative Council the responsibility of appointing
6 judges of the Tohono O'Odham Courts; and

7 WHEREAS, a vacancy exists of one full time Judge's position to fill
8 the unexpired term of former Judge Hilda A. Manuel; and

9 WHEREAS, the Legislative Council did interview candidates for the
10 Judge's position and did review the candidates'
11 qualifications; and

12 WHEREAS, the Tohono O'Odham Legislative Council has considered the
13 qualifications of the applicants and is prepared to make
14 an appointment to fill the unexpired term.

15 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
16 Council that it hereby certifies the appointment of
17 Mary A. Juan as a full time Judge of the Tohono O'Odham
18 Courts to fill the two year unexpired term of former Judge
19 Hilda A. Manuel; said two year term expires on February
20 1, 1993.

21 The foregoing Resolution was passed by the Tohono O'odham Council
22 on the 5th. day of June, 1991 at a meeting at which a quorum was
23 present with a vote of 875.5 for; 650.0 against; 198.5 not
24 voting; -0- absent, pursuant to the powers vested in the Council
25 by Section 4 of Article VIII of the Constitution of the Tohono
O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section
16 of the Act of June 18, 1934 (48 Stat. 984).
