

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Social Services Program - Final Allocation)

2 WHEREAS, the Tohono O'odham Nation is presently operating the  
3 Social Services Program under FY 1991 P.L. 93-638 contract  
4 with the Bureau of Indian Affairs; and

5 WHEREAS, such funds are available for obligation to reflect final  
6 funding for FY 1991; and

7 WHEREAS, any amendments affecting the funding or funding levels of  
8 the contract shall be submitted for review and approval  
9 by the Tohono O'odham Legislative Council; and

10 WHEREAS, an amendment has been submitted for review and approval  
11 by the Social Services Program.

12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative  
13 Council does hereby approve the amendment to the Social  
14 Services contract and authorizes expenditures in  
15 accordance with the attached budget.

16 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council  
17 that the Tohono O'odham Nation's Officials, to wit: the  
18 Chairman, Vice Chairman and any designated official are  
19 hereby authorized to negotiate and execute the contract,  
20 provided however, that any amendments affecting the  
21 funding or funding levels of the contract shall be  
22 submitted for further prior approval by this Council.

23 The foregoing Resolution was passed by the Tohono O'odham Council  
24 on the 7th day of June, 1991 at a meeting at which a quorum was  
25 present with a vote of 1,667.0 for; -0- against; 57.0 not voting;  
26 01 absent, pursuant to the powers vested in the Council by Section  
27 1 (f) of Article VI of the Constitution of the Tohono O'odham  
28 Nation, adopted by the Tohono O'odham Nation on January 18, 1986,  
and approved by the Acting Deputy Assistant Secretary - Indian  
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of  
the Act of June 18, 1934 (48 Stat. 984).
