

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Adult Group Home Program - Final Allocation)

2 WHEREAS, the Tohono O'odham Nation is presently operating the Adult  
3 Group Home Program under FY 1991 P.L. 93-638 contract with  
4 the Bureau of Indian Affairs; and

5 WHEREAS, the Tohono O'odham Nation has been informed of FY 1991  
6 final allocation received; and

7 WHEREAS, such funds made available for obligation have reflected  
8 a decrease in funding for FY 1991; and

9 WHEREAS, any amendments affecting the funding or funding levels of  
10 the contract shall be submitted for review and approval  
11 by the Tohono O'odham Legislative Council; and

12 WHEREAS, an amendment has been submitted for review and approval  
13 by the Adult Group Home Program.

14 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative  
15 Council does hereby approve the amendment to the Adult  
16 Group Home contract and authorizes expenditures in  
17 accordance with the attached budget.

18 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council  
19 that the Tohono O'odham Nation's Officials, to wit: the  
20 Chairman, Vice Chairman and any designated official are  
21 hereby authorized to negotiate and execute the contract,  
22 provided however, that any amendments affecting the  
23 funding or funding levels of the contract shall be  
24 submitted for further prior approval by this Council.

25 The foregoing Resolution was passed by the Tohono O'odham Council  
26 on the 7th day of June, 1991 at a meeting at which a quorum was  
27 present with a vote of 1,724.0 for; -0- against; -0- not voting;  
28 04 absent, pursuant to the powers vested in the Council by Section  
1 (f) of Article VI of the Constitution of the Tohono O'odham  
Nation, adopted by the Tohono O'odham Nation on January 18, 1986,

3 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of  
4 the Act of June 18, 1934 (48 Stat. 984).
