

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Credit and Finance Program Budget Modification Reflecting Final
Allocation and Carryover Funds)

2 WHEREAS, the Tohono O'odham Nation is presently operating the
3 Credit and Finance Program under FY 1991 P.L. 93-638
4 contract with the Bureau of Indian Affairs; and

5 WHEREAS, such funds are available for obligation to reflect final
6 funding for FY 1991 and carryover savings from the FY 1990
7 contract; and

8 WHEREAS, any amendments affecting the funding or funding levels of
9 the contract shall be submitted for review and approval
10 by the Tohono O'odham Legislative Council; and

11 WHEREAS, an amendment has been submitted for review and approval
12 by the Credit and Finance Program.

13 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
14 Council does hereby approve the amendment to the Credit
15 and Finance contract and authorizes expenditures in
16 accordance with the attached budget.

17 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
18 that the Tohono O'odham Nation's Officials, to wit: the
19 Chairman, Vice Chairman and any designated official are
20 hereby authorized to negotiate and execute the contract,
21 provided however, that any amendments affecting the
22 funding or funding levels of the contract shall be
23 submitted for further prior approval by this Council.

24 The foregoing Resolution was passed by the Tohono O'odham Council
25 on the 7th day of June, 1991 at a meeting at which a quorum was
26 present with a vote of 1,444.0 for; 114.0 against; 166.0 not
27 voting; 02 absent, pursuant to the powers vested in the Council
28 by Section 1 (f) of Article VI of the Constitution of the Tohono
O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section
16 of the Act of June 18, 1934 (48 Stat. 984).
