NO. 91-259 2 WHEREAS, the Tohono O'odham Nation is presently operating the 3 Credit and Finance Program under FY 1991 P.L. 93-638 4 contract with the Bureau of Indian Affairs; and WHEREAS, such funds are available for obligation to reflect final 5 6 funding for FY 1991 and carryover savings from the FY 1990 7 contract; and WHEREAS, any amendments affecting the funding or funding levels of 8 the contract shall be submitted for review and approval 9 by the Tohono O'odham Legislative Council; and 10 WHEREAS, an amendment has been submitted for review and approval by the Credit and Finance Program. 12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby approve the amendment to the Credit 14 and Finance contract and authorizes expenditures in 15 accordance with the attached budget. 16 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's Officials, to wit: the 18 Chairman, Vice Chairman and any designated official are 19 hereby authorized to negotiate and execute the contract, 20 provided however, that any amendments affecting the 21 funding or funding levels of the contract shall be 22submitted for further prior approval by this Council. 23 24 The foregoing Resolution was passed by the Tohono O'odham Council on the <u>7th</u> day of <u>June, 1991</u> at a meeting at which a quorum was present with a vote of 1.444.0 for; 114.0 against; 166.0 not voting; 02 absent, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,

1986, and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section

28 16 of the Act of June 18, 1934 (48 Stat. 984).
