WHEREAS, the Tohono O'odham Nation has consistently supported the nurturance of its young members by providing for their welfare through various programs and services designed to meet their special needs; and

WHEREAS, the Child Day Care Services Program has been successfully operated through the Early Childhood Division and has served many young Tohono O'odham children; and

WHEREAS, the Tohono O'odham Legislative Council is desirous of continuing this program for the benefit of its young members; and

WHEREAS, the Tohono O'odham Nation has previously applied for and received funding to operate the Child Day Care Services Program from the State of Arizona, Department of Economic Security, Block Grant Administration, Title XX Day Care; and

WHEREAS, the Tohono O'odham Legislative Council has reviewed the proposed contract finds the same to benefit the Child Day Care Services Program.

WHEREAS, the Tohono O'odham Legislative Council did approve by Resolution No. 91-100 a Wage and Pay Classification Study to be implemented on October 01, 1991; and

WHEREAS, Resolution No. 91-100 requested that before formal implementation, of any and all pay changes, a full disclosure of the fiscal impact of the Plan will be presented by the Executive Branch to the Tohono O'odham Legislative Council.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby approve the proposed contract for Title XX Child Day Care Services.

BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's Officials, to wit: The Chairman, Vice Chairman and any designated official are hereby authorized to negotiate and execute the contract, provided however, that any amendments affecting the funding or funding levels of this contract shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 7th day of June, 1991 at a meeting at which a quorum was present with a vote of 1,537.5 for; -0- against; 186.5 not voting; 03 absent, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




