

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'Odham FY 1992 Social Services Re-Contract Proposal)

RES. NO. 91-265

1 WHEREAS, the Tohono O'Odham Nation is presently operating the
2 Social Services Program under FY 1991 P. L. 93-638
3 contract with the Bureau of Indian Affairs; and

4 WHEREAS, such tribal operations have been successful and
5 beneficial to the Tohono O'Odham Nation and its people;
6 and

7 WHEREAS, 25, CFR 271.20 of the Federal Regulations requires that
8 all proposals to recontract under P. L. 93-638 be
9 submitted to the Tohono O'Odham Legislative Council for
10 approval at least 120 days prior to the contract
11 termination; and

12 WHEREAS, the Tohono O'Odham Nation does desire to re-contract
13 for provision of services during FY 1992; and

14 WHEREAS, the Tohono O'Odham Legislative Council has reviewed and
15 approved the FY 1992 Social Services contract proposal
16 and budget.

17 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
18 Council that it does authorize and request the Bureau
19 of Indian Affairs to re-contract with the Tohono
20 O'Odham Nation under P. L. 93-638 regulations and
21 procedures for the provision of services titled:
22 Social Services.

23 BE IT FURTHER RESOLVED that the duration of this contract shall
24 commence on October 01, 1991 through September 30,
25 1992.

26 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
27 that the Tohono O'Odham Nation will not fund or operate

the program in the interim while negotiations are still being conducted and no executed contract has been approved by the Bureau of Indian Affairs unless the agency authorizes and approves pre-award cost consistent with the Indian Self Determination Act, as amended and relevant contract regulations.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's officials, to wit: the Chairman, Vice Chairman and designated official are hereby authorized to negotiate and execute the contract, provided however, that any amendments affecting the funding or funding levels of the contract shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 18th. day of June, 1991 at a meeting at which a quorum was present with a vote of 1,724.0 for; -0- against; -0- not voting; -0- absent, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




