12 affecting the funding or funding levels of the contract
13 shall be submitted for further prior approval by this
14 Council.

15 The foregoing Resolution was passed by the Tohono O'odham Council
16 on the 18th. day of June, 1991 at a meeting at which a quorum was
17 present with a vote of 1,724.0 for; -0- against; -0- not
18 voting; -0- absent, pursuant to the powers vested in the Council
19 by Section 1(f) of Article VI of the Constitution of the Tohono
20 O'odham Nation, adopted by the Tohono O'odham Nation on January
21 18, 1986, and approved by the Acting Deputy Assistant Secretary -
22 Indian Affairs (Operations) on March 6, 1986, pursuant to Section
23 16 of the Act of June 18, 1934 (48 Stat. 984).
