

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Waiver of Indirect Cost for the  
Equal Employment Opportunity Commission)

4 WHEREAS, the Tohono O'Odham Nation established a policy to  
5 require the inclusion of indirect costs in all third  
6 party funded agreements; and

7 WHEREAS, the policy provides for an exception and waiver of the  
8 requirement by the Legislative Council if it is in the  
9 best interest of the Nation to do so, that is when the  
10 benefits to the Nation exceeds the need to collect the  
11 revenues from the funding agency; and

12 WHEREAS, funding from the U.S. Equal Employment Opportunity  
13 Commission for the FY 1992 Equal Employment Opportunity  
14 Commission/TERO Program is insufficient to cover both  
15 direct and indirect cost needs of the program.

16 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative  
17 Council finds that it is in the best interest of the  
18 Nation to waive the indirect cost funding requirement  
19 for FY 1992 Equal Employment Opportunity Commission.

20 The foregoing Resolution was passed by the Tohono O'odham Council  
21 on the 18th. day of June, 1991 at a meeting at which a quorum was  
22 present with a vote of 1,660.5 for; -0- against; 63.5 not  
23 voting; -0- absent, pursuant to the powers vested in the Council  
24 by Section 1(f) of Article VI of the Constitution of the Tohono  
25 O'odham Nation, adopted by the Tohono O'odham Nation on January  
26 18, 1986, and approved by the Acting Deputy Assistant Secretary -  
27 Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
28 16 of the Act of June 18, 1934 (48 Stat. 984).
