## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (FY 1992 Food Distribution Program Supplemental Request)

1 2 RES. NO. 91-281 WHEREAS, the Tohono O'Odham Nation does operate the Food 3 Distribution Program under a grant with the United 4 States Department of Agriculture; and 5 WHEREAS, the Food Distribution Program has been successful in 6 providing services to eligible O'Odham members; and 7 the United States Department of Agriculture has WHEREAS. 8 informed the Tohono O'Odham Nation that any cost 9 associated with the Nation's building is the 10 responsibility of the Nation; and 11 WHEREAS, the Food Distribution Program has prepared a tribal 12 supplemental request to cover cost of telephone and 13 building for a total request of \$6,068.75. 14 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative 15 Council does hereby approve the supplemental request 16 for telephone and building costs and authorizes 17 expenditures in accordance with the attached budget 18 entitled "Dollar Match". 19 20 21

The foregoing Resolution was passed by the Tohono O'odham Council on the 19th. day of June, 1991 at a meeting at which a quorum was present with a vote of 1,724.0 for; -0- against; -0- not voting; -0- absent, pursuant to the powers vested in the Council by Section 1(d) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
