15	from July 01, 1991 through June 30, 1992.

18	the program in the interim while negotiations are still
19	being conducted and no executed grant has been awarded
20	by the Inter-Tribal Council of Arizona.
21	BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Counci
22	that the Tohono O'Odham Nation's officials, to wit

the Chairman, Vice Chairman and any designated official
are hereby authorized to negotiate and execute the
grant, provided however, that any amendments affecting
the funding or funding levels of the grant shall be
submitted for further prior approval by this Council.
