

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Waiver of Indirect Cost for the  
Women, Infant, and Children)

3 WHEREAS, the Tohono O'Odham Nation established a policy to  
4 require the inclusion of indirect costs in all third  
5 party funded agreements; and

6 WHEREAS, the policy provides for an exception and waiver of the  
7 requirement by the Legislative Council if it is in the  
8 best interest of the Nation to do so, that is when the  
9 benefits to the Nation exceeds the need to collect the  
10 revenues from the funding agency; and

11 WHEREAS, funding from the Inter-Tribal Council of Arizona for  
12 FY 1992 Women, Infant, and Children Program is  
13 insufficient to cover both direct and indirect cost  
14 needs of the program.

15 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative  
16 Council finds that it is in the best interest of the  
17 Nation to waive the indirect cost funding requirement  
18 for FY 1992 Women, Infant, and Children Program.

19 The foregoing Resolution was passed by the Tohono O'odham Council  
20 on the 19th. day of June, 1991 at a meeting at which a quorum was  
21 present with a vote of 1,597.0 for; -0- against; 127.0 not  
22 voting; 02 absent, pursuant to the powers vested in the Council  
23 by Section 1(f) of Article VI of the Constitution of the Tohono  
24 O'odham Nation, adopted by the Tohono O'odham Nation on January  
25 18, 1986, and approved by the Acting Deputy Assistant Secretary -  
26 Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
27 16 of the Act of June 18, 1934 (48 Stat. 984).
