WHEREAS, the Job Training Partnership Act was enacted into law in 1982 replacing the Comprehensive Employment Training Act (CETA); and

WHEREAS, funding is made available to tribal government prospects for eligible persons through the designation of service delivery area; and

WHEREAS, the Nation is entitled to JTPA funds to develop a network of employment training programs throughout the Nation; and

whereas, the Indian Reservations in Arizona have been designated as service delivery area and are eligible to receive Federal JTPA funds; and

WHEREAS, the Tohono O'Odham Nation JTPA Program may apply for Federal JTPA funds pursuant to Master Plan Agreement with the Department of Labor.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it hereby approves the Master Plan with the Department of Labor for the delivery of JTPA services on the Tohono O'Odham Nation.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's Officials, to wit: the Chairman, Vice Chairman and any designated official are hereby authorized to negotiate and execute this Master Plan and any amendments thereto for the duration
