

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(JTPA/DOL Master Plan Designation)

3 WHEREAS, the Job Training Partnership Act was enacted into law
4 in 1982 replacing the Comprehensive Employment Training
5 Act (CETA); and

6 WHEREAS, funding is made available to tribal government
7 prospects for eligible persons through the designation
8 of service delivery area; and

9 WHEREAS, the Nation is entitled to JTPA funds to develop a
10 network of employment training programs throughout the
11 Nation; and

12 WHEREAS, the Indian Reservations in Arizona have been designated
13 as service delivery area and are eligible to receive
14 Federal JTPA funds; and

15 WHEREAS, the Tohono O'Odham Nation JTPA Program may apply for
16 Federal JTPA funds pursuant to Master Plan Agreement
17 with the Department of Labor.

18 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
19 Council that it hereby approves the Master Plan with
20 the Department of Labor for the delivery of JTPA
21 Services on the Tohono O'Odham Nation.

22 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
23 that the Tohono O'Odham Nation's Officials, to wit:
24 the Chairman, Vice Chairman and any designated official
25 are hereby authorized to negotiate and execute this
26 Master Plan and any amendments thereto for the duration

of the Plan provided however, that any amendments affecting the service designation levels of this Plan shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 19th. day of June, 1991 at a meeting at which a quorum was present with a vote of 1,592.0 for; 132.0 against; -0- not voting; 03 absent, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




