

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Waiver of Indirect Cost for the
Head Start Program Grant)

3 WHEREAS, the Tohono O'Odham Nation established a policy to
4 require the inclusion of indirect costs in all third
5 party funded agreements; and

6 WHEREAS, the policy provides for an exception and waiver of the
7 requirement by the Legislative Council if it is in the
8 best interest of the Nation to do so, that is when the
9 benefits to the Nation exceeds the need to collect the
10 revenues from the funding agency; and

11 WHEREAS, funding from the Department of Health and Human
12 Services Administration for Children, Youth and
13 Families for FY 1992 Head Start Program Grant is
14 insufficient to cover both direct and indirect cost
15 needs of the program.

16 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative
17 Council finds that it is in the best interest of the
18 Nation to waive the indirect cost funding requirement
19 for FY 1992 Head Start Program Grant.

20 The foregoing Resolution was passed by the Tohono O'odham Council
21 on the 18th. day of June, 1991 at a meeting at which a quorum was
22 present with a vote of 958.5 for; 363.5 against; 402.5 not
23 voting; 02 absent, pursuant to the powers vested in the Council
24 by Section 1(f) of Article VI of the Constitution of the Tohono
25 O'odham Nation, adopted by the Tohono O'odham Nation on January
26 18, 1986, and approved by the Acting Deputy Assistant Secretary -
27 Indian Affairs (Operations) on March 6, 1986, pursuant to Section
28 16 of the Act of June 18, 1934 (48 Stat. 984).
