

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Child Adult Care Food Services Budget)

RES. NO. 91-323

1 WHEREAS, the Tohono O'Odham Nation has operated successfully an
2 Early Childhood Headstart, Day Care Program for its young
3 members; and

4 WHEREAS, the Department of Economic Security, through a Child
5 Adult Care Food Services Financial Agreement, provides
6 funds for certain eligible services; and

7 WHEREAS, the Early Childhood Headstart, Day Care Program did
8 submit for review and approval the Child Adult Care
9 Financial Agreement per Resolution No. 302-90 to receive
10 funding in the form of reimbursements; and

11 WHEREAS, during Fiscal Years 1989 and 1990 the Early Childhood
12 Headstart, Day Care Program did submit monthly food and
13 supply claims for reimbursement; and

14 WHEREAS, reimbursements for food care claims in the amount of
15 \$89,483.96 have been received; and

16 WHEREAS, the Early Childhood Headstart, Day Care Program has
17 submitted for review and approval the attached budget.

18 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
19 Council that it does hereby approve and authorize
20 expenditures in accordance with the attached budget.

21 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
22 that the Tohono O'Odham Nation's Officials, to wit: the
23 Chairman, Vice Chairman and any designated official are
24 hereby authorized to negotiate and execute the grant,
25 provided however, that any amendments affecting the
26 funding or funding levels of the grant shall be submitted
27 for further prior approval by this Council.

2 The foregoing Resolution was passed by the Tohono O'odham Council
3 on the 11th day of July, 1991 at a meeting at which a quorum was
4 present with a vote of 1,724.0 for; -0- against; -0- not voting;
5 02 absent, pursuant to the powers vested in the Council by Section
6 1(f) of Article VI of the Constitution of the Tohono O'odham
7 Nation, adopted by the Tohono O'odham Nation on January 18, 1986,
8 and approved by the Acting Deputy Assistant Secretary - Indian
9 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
10 the Act of June 18, 1934 (48 Stat. 984).
