NO. 91-327 2 WHEREAS, the San Lucy District has adopted a Comprehensive Housing 3 Strategy that will address the overall housing needs of 4 the District, for decent and safe housing for the 5 membership of the San Lucy District; and 6 the San Lucy District, based upon the Comprehensive WHEREAS. 7 Housing Strategy, did enact Resolution 04-32-89. 8 implementing Phase I of the Housing Rehabilitation 9 project; and 10 WHEREAS, the Tohono O'Odham Legislative Council did approve and 11 authorize Phase I of the San Lucy District Housing 12 Rehabilitation project, by resolution number 208-90; and 13 the San Lucy District has substantially completed Phase WHEREAS. 14 I of the District Housing Rehabilitation: and 15 WHEREAS, the San Lucy District has determined it is in the best 16 interests, of the District, to continue the housing 17 Rehabilitation, by authorizing and implementing Phase II, 18 thereof; and 19 WHEREAS, the San Lucy District Council did authorize, by 20 Resolution 6-20-91, the allocation of Public Law 99-503 21 Settlement Funds, in the amount of \$1,330,615.13 (One 22 million three hundred thirty thousand six hundred fifteen 23 and 13/100 Dollars), in order to fund the rehabilitation 24 of the next group of 34 units; and 25 WHEREAS, the Tohono O'Odham Legislative Council continues to 26 recognize the housing needs of the San Lucy District; and 27

for implementation of Phase II of the San Lucy Housing Rehabilitation Program 1 Page (2) 2 WHEREAS, Public Law 99-503 (enacted on October 20, 1986) does 3 allow the use of settlement funds for the provision of 4 housing rehabilitation. 5 NOW, THEREFORE, BE IT RESOLVED THAT, the Tohono O'Odham Legislative 6 Council has determined that it is appropriate, and in the 7 best interests of the Tohono O'Odham Nation and the San 8 Lucy District, to authorize the allocation of P.L. 9 99-503 funds, in the amount of \$1,330,615.13, to fund 10 Phase II of the San Lucy District's Housing 11 Rehabilitation and Comprehensive Housing Strategy. 12 BE IT FURTHER RESOLVED THAT, the Tohono O'Odham Legislature does 13 appropriate the \$1,330,615.13 in accordance with the 14 budget reviewed by the Legislative Council and in 15 accordance with the policies and procedures established 16 by the Tohono O'Odham Nation for the purpose of enacting 17 Phase II of the San Lucy District's Housing 18 Rehabilitation and Comprehensive Housing Strategy. 19 The foregoing Resolution was passed by the Tohono O'odham Council 20 on the 11th. day of July, 1991 at a meeting at which a quorum was present with a vote of 1,617.0 for; -0- against; -0- not voting; 21 107.0 [6] absent, pursuant to the powers vested in the Council by Section 1(d)(3) of Article VI of the Constitution of the Tohono 22 O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -23 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). 24 TOHONO O'ODHAM LEGISLATIVE COUNCIL 25 26 Mary Ann Antone, Legislative Chairwoman
