1 WHEREAS, the Sif-Oidak District Council has reviewed and
2 considers its proposed activities for FY 1991/1992 and
3 have prepared a budget according to its proposed
4 expenditures; and

5 WHEREAS, the Sif-Oidak District Council is proposing an amount
6 of \$209,086.00 to cover the FY 1992 budget which will
7 commence on August 01, 1991 through July 31, 1992; and


8 WHEREAS, the Sif-Oidak District has sufficient funds to cover

13 Council that it does hereby approve and adopt the Sif-
14 Oidak District FY 1992 budget in the amount of

22 Nation, adopted by the Tohono O'odham Nation on January 18, 1986,
and approved by the Acting Deputy Assistant Secretary - Indian
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
the Act of June 18, 1934 (48 Stat. 984).
