

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Community Oriented Primary Care
Budget Modification No. 1 and Extension)

2 WHEREAS, the Tohono O'Odham Nation is operating a Community
3 Oriented Primary Care Demonstration Project through the
4 National Rural Health Association, Hospital Research
5 and Education Trust; and

6 WHEREAS, any amendments affecting the funding levels or grant
7 period shall be submitted for review and approval; and

8 WHEREAS, the funding agency has approved an extension of the
9 grant period through February 29, 1992; and

10 WHEREAS, the Tohono O'Odham Health Department has submitted for
11 review and approval a budget modification to cover the
12 extension period.

13 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
14 Council that it does hereby approve the budget
15 modification and extension of the grant period through
16 February 29, 1992.

17 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
18 that the Tohono O'Odham Nation's Officials, to wit: the
19 Chairman, Vice Chairman and any designated official are
20 hereby authorized to negotiate and execute the grant,
21 provided however, that any amendments affecting the
22 funding levels of this grant shall be submitted for
23 further prior approval by this Council.

24 The foregoing Resolution was passed by the Tohono O'Odham Council
25 on the 5th day of August, 1991 at a meeting at which a quorum was
26 present with a vote of 1,724.0 for; -0- against; -0- not voting;
27 04 absent, pursuant to the powers vested in the Council by Section
28 1(f) of Article VI of the Constitution of the Tohono O'Odham
Nation, adopted by the Tohono O'Odham Nation on January 18, 1986,
and approved by the Acting Deputy Assistant Secretary - Indian
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
the Act of June 18, 1934 (48 Stat. 984).
