

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Women, Infant and Children Budget Modification No. 3)

RES. NO. 91-337

1 WHEREAS, the Tohono O'Odham Nation is presently operating the
2 Women, Infant and Children Program; and

3 WHEREAS, funding for the operation of the Women, Infant and
4 Children Program has been possible from the United
5 States Department of Agriculture through administration
6 by the Inter-Tribal Council of Arizona; and

7 WHEREAS, the Women, Infant and Children Program has submitted
8 a budget modification for FY 1991 for additional
9 funding in the amount of \$7,000.00 to be used for the
10 purchase of nutrition and education materials targeted
11 at childhood obesity and for staff development courses.

12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
13 Council that it hereby approves the budget modification
14 for additional funding in the amount of \$7,000.00 for
15 the Women, Infant and Children Program and authorizes
16 expenditures in accordance with the attached budget.

17 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
18 that the Tohono O'Odham Nation's Officials, to wit: the
19 Chairman, Vice Chairman and any designated official are
20 hereby authorized to negotiate and execute the
21 agreement, provided however, that any amendments
22 affecting the funding or funding levels of this
23 agreement shall be submitted for further prior approval
24 by this Council.

25 The foregoing Resolution was passed by the Tohono O'odham Council
26 on the 5th day of August, 1991 at a meeting at which a quorum was
27 present with a vote of 1,724.0 for; -0- against; -0- not voting;
28 04 absent, pursuant to the powers vested in the Council by Section
1(f) of Article VI of the Constitution of the Tohono O'odham

1 Nation, adopted by the Tohono O'odham Nation on January 18, 1986,
2 and approved by the Acting Deputy Assistant Secretary - Indian
3 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
4 the Act of June 18, 1934 (48 Stat. 984).
