

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Parent/Child Center Expansion Proposal)

RES. NO. 91-339

1 WHEREAS, the Tohono O'Odham Headstart Program has prepared a
2 submittal for a proposal for a Parent/Child Center
3 Expansion Program; and

4 WHEREAS, the proposal is geared at a comprehensive child
5 development and family support program for low income
6 pregnant women and children from birth through 3 years
7 of age; and

8 WHEREAS, the program is designed to develop program approaches,
9 processes and techniques aimed at preventing the
10 development of health, intellectual, social and
11 emotional deficiencies in the child 0-3 years of age:
12 and

13 WHEREAS, the program is also designed to strengthen and improve
14 parents various skills confidence and awareness of
15 their roles as adults and as the principle influences
16 of their child's life.

17 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative
18 Council hereby approves the Parent/Child Center
19 Expansion Program proposal to be submitted to the
20 United States Department of Health and Human Services,
21 Administration on Children, Youth and Families.

22 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
23 that the duration of the grant shall commence on the
24 date of award for a period of one year.

25 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
26 that the Tohono O'Odham Nation's Officials, to wit: the
27 Chairman, Vice Chairman and any designated official are

2 hereby authorized to negotiate and execute the grant,
3 provided however, that any amendments affecting the
4 funding or funding levels of the grant shall be
5 submitted for further prior approval by this Council.

6 The foregoing Resolution was passed by the Tohono O'odham Council
7 on the 5th. day of August, 1991 at a meeting at which a quorum
8 was present with a vote of 1,597.0 for; -0- against; 127.0 not
9 voting; 04 absent, pursuant to the powers vested in the Council
10 by Section 1(f) of Article VI of the Constitution of the Tohono
11 O'odham Nation, adopted by the Tohono O'odham Nation on January
12 18, 1986, and approved by the Acting Deputy Assistant Secretary -
13 Indian Affairs (Operations) on March 6, 1986, pursuant to Section
14 16 of the Act of June 18, 1934 (48 Stat. 984).


