4 on December 2 - 6, 1991; and

5 WHEREAS, the Tohono O'odham Nation is a long time member, in good
6 standing, of the National Congress of American Indians;

8 WHEREAS, the Tohono O'odham Legislative Council believes that it
9 is in the best interest of the Tohono O'odham Nation to
10 renew its membership in the National Congress of American
11 Indians.

17 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
18 the Act of June 18, 1934 (48 Stat. 984).


