Patricio as the official representative from the Tohono O'odham Nation to 18 19 the National Indian Gaming Association Board of Directors and does further authorize Andrew M. Patricio to represent 20 21 the Region on the Executive Committee of the National 22 Indian Gaming Association. 23 The foregoing Resolution was passed by the Tohono O'odham Council on the <u>8th</u> day of <u>August, 1991</u> at a meeting at which a quorum was 24 present with a vote of 1,724.0 for; -0- against; -0- not voting; 06 absent, pursuant to the powers vested in the Council by Section 1(b) of Article VI of the Constitution of the Tohono O'odham **2**5 Nation, adopted by the Tohono O'odham Nation on January 18, 1986, 26 and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of 27 the Act of June 18, 1934 (48 Stat. 984).
