(Appointing Official Representative to the National
Indian Gaming Association)

2 WHEREAS, Tohono O'odham Legislative Council delegated the
3 Legislative Commerce Committee as the oversight on Indian
4 Gaming; and

5 WHEREAS, the Commerce Committee has actively participated in the
6 National Indian Gaming Association (NIGA) meetings; and

7 WHEREAS, the primary objective and purpose of the National Indian
8 Gaming Association is to promote, protect and preserve
9 Indian Gaming enterprises in Indian Country; and

10 WHEREAS, the Tohono O'odham Nation is now a chartered member of the
11 National Indian Gaming Association (NIGA); and

12 WHEREAS, the Commerce Committee recommends that Andrew M. Patricio
13 be appointed as the official representative to the
14 National Indian Gaming Association (NIGA) Board of
15 Directors to replace Mary Ann Antone.

16 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
17 Council does hereby appoint Andrew M. Patricio as the
18 official representative from the Tohono O'odham Nation to
19 the National Indian Gaming Association Board of Directors
20 and does further authorize Andrew M. Patricio to represent
21 the Region on the Executive Committee of the National
22 Indian Gaming Association.

23 The foregoing Resolution was passed by the Tohono O'odham Council
24 on the 8th day of August, 1991 at a meeting at which a quorum was
25 present with a vote of 1,724.0 for; -0- against; -0- not voting;
26 06 absent, pursuant to the powers vested in the Council by Section
27 1(b) of Article VI of the Constitution of the Tohono O'odham
28 Nation, adopted by the Tohono O'odham Nation on January 18, 1986,
and approved by the Acting Deputy Assistant Secretary - Indian
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
the Act of June 18, 1934 (48 Stat. 984).
