1 RES. NO. 91-348 2 WHEREAS, by Resolution No. 91-180 the Tohono O'odham Legislative 3 Council adopted the recommendations of the Water Resources Committee regarding recharge, the 9B Farm and other 4 alternatives for use of the Central Arizona Project 5 ("CAP") water granted under the Southern Arizona Water 6 Rights Settlement Act of 1982 ("SAWRSA"); and WHEREAS, the foregoing Resolution directed that a technical expert 8 be engaged to refine the options for recharge, including 9 recharge at the sites identified in the recharge 10 feasibility study; and 11 WHEREAS, the Water Resources Committee recommends that a Consultant 12 Contract be entered into with Natural Resources Consulting 13 Engineers to conduct this assessment; and 14 WHEREAS, funding for the recommended Contract is a permissible 15 expenditure of dividends and interest on the Trust Fund 16 established under Section 309 of SAWRSA (the "SAWRSA Trust 17 Fund"), in that the Contract is designed to assist in the 18 Nation's "development of water resources." 19 NOW, THEREFORE, BE IT RESOLVED THAT: 20 The Tohono O'odham Legislative Council hereby approves 21 Consultant Contract with Natural 22 Consulting Engineers, in the amount of \$45,000 and in **2**3 the form attached hereto, for the purposes of refining 24 the options to recharge SAWRSA CAP water. 25

> The foregoing sum of \$45,000 shall be paid from the SAWRSA Trust Fund.
