

1 RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
2 (Tohono O'Odham Executive Office FY '91 Budget Modification)

3 RES. NO. 91-359

4 WHEREAS, the Tohono O'Odham Nation is currently operating the
5 Executive Office with tribal funds; and

6 WHEREAS, amendments affecting the funding level or change in the
7 purpose for which the funds were budgeted are required
8 to be submitted for review and approval by the Tohono
9 O'Odham Legislative Council; and

10 WHEREAS, an amendment has been submitted for review and
11 approval.

12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
13 Council that it hereby approves this amendment and
14 authorizes expenditures in accordance with the attached
15 budget.

16 The foregoing Resolution was passed by the Tohono O'odham Council
17 on the 15th day of August, 1991 at a meeting at which a quorum was
18 present with a vote of 1,425.5 for; -0- against; 132.5 not
19 voting; 166.0 [06] absent, pursuant to the powers vested in the
20 Council by Section 1(d)(2) of Article VI of the Constitution of the
21 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
22 January 18, 1986, and approved by the Acting Deputy Assistant
23 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant
24 to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
