## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Tribal Housing Inventory FYE 1991)

RES. NO. 91-360 1 WHEREAS, the Bureau of Indian Affairs has in 1986 proposed a 2 housing inventory for the purpose of distribution of 3 HIP funds in accordance with tribal housing needs 4 projected in a "Tribal Plan for use of HIP Funds"; and 5 WHEREAS, the Tohono O'Odham Nation agrees that a housing 6 inventory is necessary to justify and efficiently 7 expend HIP funds; and 8 WHEREAS, the Tohono O'Odham Nation had conducted a village to 9 village reassessment of the housing needs of the 10 reservation; and 11 WHEREAS, the reassessment has resulted in a corrected increase 12 in the total housing on the reservation from 2447 in 13 1989 to 2690. 14 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it has reviewed the 1991 Housing Inventory required by the Bureau of Indian Affairs and respectfully submits it for the Bureau funding determination. The foregoing Resolution was passed by the Tohono O'odham Council 20 on the <u>15th.</u> day of <u>August, 1991</u> at a meeting at which a quorum was present with a vote of <u>1,422.0</u> for; <u>-0-</u> against; <u>136.0</u> not 21 voting; 166.0 [6] absent, pursuant to the powers vested in the Council by Section 1(c)(2) & (j) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
