23 ***are approved, as herein above indicated.***


24 ***BE IT FURTHER RESOLVED that the Chairman and other appropriate***

11 1 (h) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
12 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy
13 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to
14 Section 16 of the Act of June 18, 1934 (48 Stat. 984).






