

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'odham Social Services Program FY 1992
Budget Modification No. 1)**

3 **WHEREAS, the Tohono O'odham Nation is presently operating the Social Services**
4 **Program under FY 1991 P. L. 93-638 contract with the Bureau of**
5 **Indian Affairs; and**

6 **WHEREAS, the Nation did submit to the Bureau of Indian Affairs its Contract**
7 **proposal for provision of services during FY 1992; and**

8
9 **WHEREAS, any amendments affecting the funding or funding levels of the**
10 **contract shall be submitted for review and approval by the Tohono**
11 **O'odham Legislative Council; and**

12 **WHEREAS, an amendment has been submitted for review and approval by the**
13 **Tohono O'odham Social Services Program reducing the General**
14 **Assistance Line Item by \$324,823.00 to fund the Employment**
15 **Assistance Readiness Network Demonstration Project Program for**
16 **Fiscal Year 1992; and**

18 **WHEREAS, the Tohono O'odham Nation does request that the Bureau of Indian**
19 **Affairs approve the reduction to the FY 1992 Tohono O'odham Social**
20 **Services Contract Budget to fund the Employment Assistance**
21 **Readiness Network Demonstration Project Program.**

23 **NOW, THEREFORE, IT BE RESOLVED that the Tohono O'odham Legislative**
24 **Council does hereby approve the amendment to the Tohono O'odham**
25 **Social Services reducing the General Assistance line item by**
26 **\$324,823.00 to fund the EARN Program.**

27 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council**

28 **that the Tohono O'odham Nation's officials, to wit: the Chairman,**

Vice Chairman and any designated official are hereby authorized to negotiate and execute the contract, provided however, that any amendments affecting the funding or funding levels of the contract shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 10th day of September, 1991 at a meeting at which a quorum was presented with a vote of 1,618.0 FOR; -0- AGAINST; -0- NOT VOTING; and 106.0 [5] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).






