(FY 1992 Tohono O'odham Employment Assistance
Readiness Network Employment Assistance Grant)**

3 **WHEREAS, the Tohono O'odham Nation is presently operating the Employment**
4 **Assistance Readiness Network Program under FY 1991 P. L. 93-638**
5 **grant with the Bureau of Indian Affairs; and**

6 **WHEREAS, such tribal operations have been successful and beneficial to the**
7 **Tohono O'odham Nation and its people; and**

8 **WHEREAS, the Tohono O'odham Nation does desire to contract for the**
9 **continuation of the EARN initiatives during FY 1992; and**

11 **WHEREAS, the Tohono O'odham Legislative Council, per Resolution No. 91-371**
12 **did authorize the reduction of the Tohono O'odham Social Services**
13 **General Assistance line item in the amount of \$324,823.00 to fund**
14 **the EARN Program for FY 1992; and**

15 **WHEREAS, the Tohono O'odham Legislative Council has reviewed and approved**
16 **the FY 1992 EARN grant proposal and budget.**

18 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative**
19 **Council that it does authorize and request the Bureau of Indian Affairs**
20 **to contract with the Tohono O'odham Nation under P. L. 93-638**
21 **regulations and procedures for the provision of services titled:**
22 **Employment Assistance Readiness Network.**

24 **BE IT FURTHER RESOLVED that the duration of this grant shall**
25 **commence on October 01, 1991 through September 30, 1992.**

26 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council**
27 **that the Tohono O'odham Nation's Officials, to wit: the Chairman,**
28 **Vice Chairman and designated official are hereby authorized to**

negotiate and execute the grant, provided however, that any amendments affecting the funding or funding levels of the grant shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 10th day of September, 1991 at a meeting at which a quorum was presented with a vote of 1,618.0 FOR; -0- AGAINST; -0- NOT VOTING; and 106.0 [3] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




