

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Permitting Safe Ride, Inc. to provide Dialysis Transportation)**

3 **WHEREAS, the Tohono O'odham Nation, through its health department, currently**
4 **provides transportation for all dialysis patients; and**

5 **WHEREAS, dialysis transportation funding is provided for in the Community Health**
6 **Representative contract with the Indian Health Service; and**

7 **WHEREAS, said funding could be utilized for more direct health care service**
8 **delivery; and**

10 **WHEREAS, Safe Ride, Inc., a private company which specializes in the provision**
11 **of transportation services for dialysis patients and general non-**
12 **emergency transportation; and**

13 **WHEREAS, Safe Ride would provide these same services for which reimbursement**
14 **would be sought, by Safe Ride, from the Arizona Health Care Cost**
15 **Containment System (AHCCCS) with no liability to the Nation; and**

16
17 **WHEREAS, the Nation is desirous of utilizing health care resources for direct**
18 **health care service.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative**
20 **Council does hereby authorize and otherwise permit Safe Ride, Inc. to**
21 **operate its business on the Tohono O'odham Nation.**

23 **BE IT FURTHER RESOLVED that Safe Ride, Inc. shall abide by the Tribal Employment**
24 **Rights Ordinance (TERO) and other ordinances of the Nation as they**
25 **may apply in the provision of services and employment while**
26 **operating on the reservation.**



BE IT FURTHER RESOLVED that the Nation, through its Health Department will coordinate the provision of service and provide for operational support.

BE IT FINALLY RESOLVED that the permit for operations on the Tohono O'odham Nation will be for one (1) year; which will include a provision for termination of this permit with thirty (30) days notice and a provision for renewal prior to the end of the one year. That the Nation's Chairman or his delegate is hereby authorized to execute with Safe Ride an agreement for services that will be satisfactory and beneficial to the O'odham community.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 11th. day of September, 1991 at a meeting at which a quorum was presented with a vote of 1,618.0 FOR; -0- AGAINST; -0- NOT VOTING; and 106.0 [6] ABSENT, pursuant to the powers vested in the Council by Section 1 (c)(2) & Section 2 (d) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
