

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'Odham Property & Supply FY '91 Budget Modification #1)**

2 **WHEREAS, the Tohono O'Odham Nation is currently operating the Property &**
3 **Supply Program with tribal funds; and**

4 **WHEREAS, amendments affecting the funding level or change in the purpose for**
5 **which the funds were budgeted are required to be submitted for**
6 **review and approval by the Tohono O'Odham Legislative Council; and**

8 **WHEREAS, an amendment has been submitted to purchase the Dodge Van**
9 **currently being leased by the Property & Supply Program for review**
10 **and approval.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that**
12 **funds in the amount of \$6,598.00 are appropriated from general**
13 **revenues for the purpose of increasing the budget of the Property &**
14 **Supply Program.**

16 **BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council it hereby**
17 **approves this amendment and authorizes expenditures in accordance**
18 **with the attached budget.**

22 **with a vote of 1,282.0 FOR; -0- AGAINST; -0- NOT VOTING; and 422.0 [09]**
23 **ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(3) of Article**
24 **VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
the Act of June 18, 1934 (48 Stat. 984).
