

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'Odham Garage FY '91 Budget Modification #2)**

2 **WHEREAS, the Tohono O'Odham Nation is currently operating the Tohono**
3 **O'Odham Garage with tribal funds; and**

4 **WHEREAS, amendments affecting the funding level or change in the purpose for**
5 **which the funds were budgeted are required to be submitted for**
6 **review and approval by the Tohono O'Odham Legislative Council; and**

8 **WHEREAS, an amendment has been submitted for review and approval to**
9 **purchase office communication equipment and a balancer.**

10 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that**
11 **funds in the amount of \$4,950.00 are appropriated from general**
12 **revenues for the purpose of increasing the budget of the Tohono**
13 **O'Odham Garage.**

15 **BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that**
16 **it hereby approves this amendment and authorizes expenditures in**
17 **accordance with the attached budget.**

19 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on**
20 **the 12th. day of September, 1991 at a meeting at which a quorum was presented**
21 **with a vote of 1,282.0 FOR; -0- AGAINST; -0- NOT VOTING; and 422.0 [9]**
22 **ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(3) of Article**
23 **VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
24 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**
26 **the Act of June 18, 1934 (48 Stat. 984).**
