4 **O'Odham Grants & Contracts with tribal funds; and**

5 **WHEREAS, amendments affecting the funding level or change in the purpose for**
6 **which the funds were budgeted are required to be submitted for**
7 **review and approval by the Tohono O'Odham Legislative Council; and**

8 **WHEREAS, an amendment has been submitted for review and approval to transfer**
9 **funds between line items, and purchase office equipment.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that**
12 **it hereby approves this amendment and authorizes expenditures in**
13 **accordance with the attached budget.**

14 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on**
15 **the 12th. day of September, 1991 at a meeting at which a quorum was presented**
16 **with a vote of 1,282.0 FOR; -0- AGAINST; -0- NOT VOTING; and 422.0 [9]**
17 **ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(3) of Article**
18 **VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
19 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**
21 **the Act of June 18, 1934 (48 Stat. 984).**


