3 **WHEREAS, the Tohono O'odham Nation has successfully operated the Diabetes**
4 **Prevention Program since November, 1989 through a grant from the**
5 **Robert Wood Johnson Foundation; and**

6 **WHEREAS, the Tohono O'odham Nation has established the elimination of**
7 **diabetes mellitus as a health promotion and disease prevention goal;**
8 **and**

10 **WHEREAS, due to the slow start of the program operations and staff recruitment**
11 **during Year One and Year Two, and in order to achieve the goals and**
12 **objectives of the project, it was necessary to request for one year**
13 **extension of the grant; and**

14 **WHEREAS, the Tohono O'odham Health Department does submit for review and**
15 **approval a budget for FY 1992 and an extension of the grant for one**
16 **year; and**

18 **WHEREAS, the extension request will be funded with savings identified in Year**
19 **One of the grant.**

20 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that**
21 **it hereby approves the extension-request and authorizes expenditures**
22 **in accordance with the attached budget.**

24 **BE IT FURTHER RESOLVED that the duration of the extension will begin on September**
25 **01, 1991 through August 31, 1992 for Year Three of the grant.**

26 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the**
27 **Tohono O'odham Nation's Officials, to wit: the Chairman, Vice-**
