2 WHEREAS, the Gu Achi District Council has considered and reviewed its District
3 Budget for FY 92 and has prepared a budget to cover anticipated cost
4 and expenses for FY 92; and

5 WHEREAS, the Gu Achi District Council did adopt and approve the budget for FY
6 92 in the amount of \$211,385.37; and

8 WHEREAS, the Tohono O'Odham Legislative Council has reviewed the budget and
9 approves of same.

10 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that
11 it hereby approves the Gu-Achi District Council Budget to be
12 expended in accordance with the attached budgets.

15 the 13th. day of September, 1991 at a meeting at which a quorum was presented
16 with a vote of 1,724.0 FOR; -0- AGAINST; -0- NOT VOTING; and 05 ABSENT,
17 pursuant to the powers vested in the Council by Section 1 (d)(3) of Article VI of the
18 Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation
on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,
1934 (48 Stat. 984).
