

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appropriating \$191,574.00 to the Administrative Provision
Budget for Elderly Program vehicles, and for well repairs)**

3 **WHEREAS, the Administrative Provision Budget is used by the Executive Branch**
4 **to fund activities of general benefit to the Nation; and**

5 **WHEREAS, ten (10) new vehicles have been requested, at a cost of**
6 **\$191,574.00, to transport participants to meals and other activities**
7 **of the Elderly Program because the program's existing vehicles are**
8 **becoming unreliable, expensive to maintain, and have no handicapped**
9 **facilities; and**

11 **WHEREAS, the Tohono O'odham Tribal Herd requests rehabilitation of one stock**
12 **well on the ranch property at a cost of \$8,216.00, and**

13 **WHEREAS, a modification to the Administrative Provision budget has been**
14 **proposed that requests an additional appropriation of \$191,574.00,**
15 **which is the total of these two amounts minus a distribution from**
16 **Contingency.**

18 **NOW, THEREFORE, BE IT RESOLVED by the Legislative Council of the T o h o n o**
19 **O'odham Nation that the sum of \$191,574.00 is appropriated from**
20 **general revenues to be added to the FY 1991 Administrative Provision**
21 **budget as shown in the attached budget modification.**

23 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on**
24 **the 13th. day of September, 1991 at a meeting at which a quorum was presented**
25 **with a vote of 1,560.0 FOR; -0- AGAINST; 57.0 NOT VOTING; and 107.0 [8]**
26 **ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(3) of Article**
27 **VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
28 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
the Act of June 18, 1934 (48 Stat. 984).
