Distribution Program under a contract with the U. S. Department of

Agriculture; and

WHEREAS, funds provided by the USDA budget and funds currently appropriated to the program by the Tohono O'odham Nation are insufficient to meet program expenses to September 30, 1991; and

WHEREAS, the Food Distribution Program has proposed a budget modification increasing the appropriation to the Program budget by \$6,500.00.

NOW, THEREFORE, BE IT RESOLVED by the Legislative Council of the T o h o n o

O'odham Nation that the sum of \$6,500.00 is appropriated from

general revenues to be added to the FY 1991 budget of the Food

Distribution Program according to the attached budget modification.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 13th. day of September, 1991 at a meeting at which a quorum was presented with a vote of 1,560.0 FOR; -0- AGAINST; 57.0 NOT VOTING; and 107.0 [7] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
