## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Waiver of Indirect Cost for the Juvenile Crime Reduction Program Grant)

1 RES. NO. 91-400 2 WHEREAS. the Tohono O'odham Nation established a policy to require the 3 4 inclusion of indirect costs in all third party funded agreements; and 5 WHEREAS, the policy provides for an exception and waiver of the requirement by 6 the Legislative Council if it is in the best interest of the Nation to do 7 so, that is when the benefits to the Nation exceeds the need to collect 8 the revenues from the funding agency; and 9 WHEREAS. funding from the Supreme Court, State of Arizona for the FY 1992 10 Juvenile Crime Reduction Program grant is insufficient to cover both 11 12 direct and indirect cost needs of the program. 13 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council 14 finds that it is in the best interest of the Nation to waive the indirect 15 cost funding requirement for FY 1992 Juvenile Crime Reduction 16 Program. 17 The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 13th. day of September, 1991 at a meeting at which a quorum was presented 19 with a vote of 1,275.0 FOR; -0- AGAINST; 342.0 NOT VOTING; and 107.0 [7] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI 20 of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary 21 - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of 22 June 18, 1934 (48 Stat. 984). 23 TOHONO O'ODHAM LEGISLATIVE COUNCIL 24
