

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Authorizing purchase of a Copier, Service Contract and**  
**Supplies by the Property and Supply Department from funds**  
**collected as copying charges)**

3 **WHEREAS, the Property and Supply Department of the Executive Branch of the**  
4 **Tohono O'Odham Nation provides copying facilities that are shared by**  
5 **the departments and programs of the Tohono O'Odham Nation; and**

6  
7 **WHEREAS, the Property and Supply Department charges these departments a per-**  
8 **copy fee that includes charges for service and replacement of the**  
9 **copy machine and for supplies; and**

10 **WHEREAS, the Department's current copier is unreliable, difficult and costly to**  
11 **maintain, and costs for future periods are expected to increase**  
12 **dramatically; and**

13  
14 **WHEREAS, the copying fees that have been accumulated by the Accounting**  
15 **Department in a separate account are currently sufficient to pay for**  
16 **a new copier, a service contract, and an initial order of supplies.**

17 **NOW, THEREFORE, BE IT RESOLVED by the Legislative Council of the Tohono**  
18 **O'Odham Nation that the Property and Supply Department is**  
19 **authorized to purchase a copier, a service contract, and supplies from**  
20 **funds accumulated for these purposes, according to the attached**  
21 **budget.**

24 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on**  
25 **the 23rd. day of September, 1991 at a meeting at which a quorum was presented**  
26 **with a vote of 1,483.0 FOR; -0- AGAINST; -0- NOT VOTING; and 241.0 [9]**  
27 **ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(3) of Article**  
28 **VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
**O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
**Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**  
**the Act of June 18, 1934 (48 Stat. 984).**
