3 **WHEREAS, the Tohono O'Odham Nation is currently operating the Tohono**
4 **O'Odham Accounting Department with tribal funds; and**

5 **WHEREAS, amendments affecting the funding level or change in the purpose for**
6 **which the funds were budgeted are required to be submitted for**
7 **review and approval by the Tohono O'Odham Legislative Council; and**


8 **WHEREAS, an amendment has been submitted for review and approval requesting**
9 **additional funds.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that**
12 **funds in the amount of \$66,672.00 are appropriated from general**
13 **revenues for the purpose of increasing the budget of the Accounting**
14 **Department.**

15 **BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that it hereby**
16 **approves this amendment and authorizes expenditures in accordance**
17 **with the attached budget.**

23 **ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(3) of Article**
24 **VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
the Act of June 18, 1934 (48 Stat. 984).
