

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval of the Tohono O'Odham Judicial Branch FY-1992  
Budget and Appropriating Funds from FY-1992 General Revenues  
in the amount of \$1,040,117.)**

**RES. NO. 91-421**

**WHEREAS, spending authority for the 1991 fiscal year for the Judicial Branch and its departments ends at midnight September 30, 1991; and**

**WHEREAS, it is necessary for the continued administration of the Judicial Branch to adopt an operating budget, to approve spending authority, and to appropriate funds for FY-1992; and**

**WHEREAS, the Judicial Branch has prepared and presented a budget that reflects the needs of the Branch for FY-1992, said budget is attached hereto and incorporated by reference; and**

**WHEREAS, the Budget and Finance Committee of the Legislative Council has reviewed this budget and recommended its approval and adoption.**

**NOW, THEREFORE, BE IT RESOLVED by the Legislative Council of the Tohono O'Odham Nation that it approves the FY-1992 budget submitted by the Judicial Branch. It is recognized that Payroll Taxes for Judicial Branch employees (in the amount of 12% of salaries) are included in these budgets; Employee Benefits related to Judicial Branch employees (in the amount of 16% salaries) are to be part of the Executive Branch budget.**

**BE IT FURTHER RESOLVED that funds in the amount of \$1,040,117.00 are hereby appropriated from the FY-1992 General Revenues of the Nation to carry out the activities supported by this budget.**






