3 **WHEREAS,** *the Agriculture Extension Program in the Executive Branch of the*
4 *Tohono O'Odham Nation receives funding through a contract with the*
5 *Bureau of Indian Affairs to pay for the program's operating expenses;*

8 **WHEREAS,** *the Agriculture Extension Program feels that this budget is not*
9 *adequate to support the type and level of service needed by the*
10 *people of the Tohono; and*

11 **WHEREAS,** *the Agriculture Extension Program has submitted a supplementary*
12 *budget (attached hereto and incorporated by reference) for approval*
13 *by the Legislative Council of the Tohono O'Odham Nation with a*
14 *request for an appropriation of funds; and*

16 **WHEREAS,** *the Agriculture Committee of the Legislative Council, with the*
17 *oversight responsibility for the Agriculture Extension Program, has*
18 *reviewed this budget and appropriation request and recommended*
19 *their approval and adoption; and*

21 **WHEREAS,** *the Budget and Finance Committee of the Legislative Council has*
22 *reviewed this budget and appropriation request and recommended*
23 *their approval and adoption.*

24 **NOW, THEREFORE, BE IT RESOLVED** *by the Legislative Council of the Tohono*
25 *O'Odham Nation that it approves the FY-1992 supplementary budget*
26 *submitted by the Agriculture Extension Program.*



**BE IT FURTHER RESOLVED that to the extent that salaries and wages are to be paid
in this budget, Payroll Taxes for Agriculture Extension Program
employees (in the amount of 12% of salaries) are included in these
budgets, and that Employee Benefits for all employees (in the amount
of 16% of salaries) are to be part of the Executive Branch budget.**


**BE IT FURTHER RESOLVED that funds in the amount of \$20,293 are hereby
appropriated from the FY-1992 General Revenues of the Nation to
carry out the activities supported by this budget.**

**The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on
the 25th day of September, 1991 at a meeting at which a quorum was presented
with a vote of 1,395.0 FOR; -0- AGAINST; 57.0 NOT VOTING; and 272.0 [10]
ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI
of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary
- Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
June 18, 1934 (48 Stat. 984).**
