8 **WHEREAS,** *the Adult Care Group Home of the Tohono O'Odham Social Service*
9 *Program feels that this budget is not adequate to support the type and*
10 *level of service needed by the people of the Tohono; and*

12 **WHEREAS,** *the Adult Care Group Home of the Tohono O'Odham Social Service*
13 *Program has submitted a supplementary budget (attached hereto and*
14 *incorporated by reference) for approval by the Legislative Council of*
15 *the Tohono O'Odham Nation with a request for an appropriation of*
16 *funds; and*

18 **WHEREAS,** *the Health & Human Services Committee of the Legislative Council,*
19 *with the oversight responsibility for the Adult Care Group Home of the*
20 *Tohono O'Odham Social Service Program, has reviewed this budget*
21 *and appropriation request and recommended their approval and*


NOW, THEREFORE, BE IT RESOLVED by the Legislative Council of the Tohono O'Odham Nation that it approves the FY-1992 supplementary budget submitted by the Adult Care Group Home of the Tohono O'Odham Social Service Program.

BE IT FURTHER RESOLVED that to the extent that salaries and wages are to be paid in this budget, Payroll Taxes for Adult Care Group Home of the Tohono O'Odham Social Service Program employees (in the amount of 12% of salaries) are included in these budgets, and that Employee Benefits for all employees (in the amount of 16% of salaries) are to be part of the Executive Branch budget.

BE IT FURTHER RESOLVED that funds in the amount of \$74,098 are hereby appropriated from the FY-1992 General Revenues of the Nation to carry out the activities supported by this budget.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 25th. day of September, 1991 at a meeting at which a quorum was presented with a vote of 1,395.0 FOR; -0- AGAINST; 57.0 NOT VOTING; and 272.0 [10] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
