11 **supplementary budget (attached hereto and incorporated by reference)**
12 **for approval by the Legislative Council of the Tohono O'Odham Nation**
13 **with a request for an appropriation of funds; and**

15 **WHEREAS, the Health & Human Services Committee of the Legislative Council,**
16 **with the oversight responsibility for the LIHEAP, has reviewed this**
17 **budget and appropriation request and recommended their approval and**
18 **adoption; and**

20 **WHEREAS, the Budget and Finance Committee of the Legislative Council has**
21 **reviewed this budget and appropriation request and recommended**
22 **their approval and adoption.**
