4 *Nation receives funding through an agreement with the Inter-Tribal*
5 *Council of Arizona to pay for the program's operating expenses; and*

7 **WHEREAS,** *the W.I.C. Program feels that this budget is not adequate to support*
8 *the type and level of service needed by the members of the Tohono*
9 *O'Odham Nation; and*

10 **WHEREAS,** *the W.I.C. Program has submitted a supplementary budget (attached*
11 *hereto and incorporated by reference) for approval by the Legislative*
12 *Council of the Tohono O'Odham Nation with a request for an*
13 *appropriation of funds; and*

15 **WHEREAS,** *the Health & Human Services Committee of the Legislative Council,*
16 *with the oversight responsibility for the W.I.C. Program, has reviewed*
17 *this budget and appropriation request and recommended their approval*
18 *and adoption; and*

20 **WHEREAS,** *the Budget and Finance Committee of the Legislative Council has*
21 *reviewed this budget and appropriation request and recommended*
22 *their approval and adoption.*

23 **NOW, THEREFORE, BE IT RESOLVED** *by the Legislative Council of the Tohono*
24 *O'Odham Nation that it approves the FY-1992 supplementary budget*
25 *submitted by the W.I.C. Program.*




BE IT FURTHER RESOLVED that funds in the amount of \$9,595 are hereby

of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary
- Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
June 18, 1934 (48 Stat. 984).
